

Blue Grass Airport's Sarasota Beach Trip Giveaway!

OFFICIAL SWEEPSTAKES RULES

*Please note: This sweepstakes prize exceeds \$600. A W-9 form will need to be filled out by the winner. (See #7)

Lexington-Fayette Urban County Airport Board (the "Board") will conduct the Sweepstakes substantially as described in these rules, and by participating, each participant agrees as follows:

- 1. Description of Sweepstakes/Participation: The Board will run an online sweepstakes on its website, social media, radio and at Blue Grass Airport to encourage fans and followers to register to win the following package: Two round-trip airfare vouchers provided by Allegiant Air, a three-night Voco Hotel stay, four days of complimentary valet parking at Blue Grass Airport, two tickets to Discover Sarasota, two tickets to Bishop Museum of Science and Nature, two tickets to Gulf Island Ferry, a Get Up & Go kayaking tour for two and a \$50 gift card to Anna Maria Oyster Bar. Contestants will be directed to the Airport Board's online sweepstakes page, where they can register to win.
- Two round-trip airfare vouchers on Allegiant Air. Tickets are coach tickets. Certain blackout dates apply. See Section 2 for prize terms. The prize winner is encouraged to book early for the best flight selection. Baggage fees are the responsibility of the winner.
- Airport valet parking will be provided for four days. Additional days of parking will be the winner's responsibility. Transportation to/from the airport is also the responsibility of the winner, along with additional spending and miscellaneous monies.
 - A. **Dates of Sweepstakes**: The Sweepstakes will begin on October 1, 2025, and conclude on October 21, 2025. NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of participants.)

2. Prize Terms and Conditions:

- A. Procedures for requesting the prize will be provided to the winner. All vouchers have no value except when redeemed in accordance with the terms and conditions listed in these Sweepstakes' rules. All vouchers are non-transferable and non-refundable. Travel vouchers provided under this agreement cannot be bartered, sold or exchanged for cash or in lieu of cash payment.
- B. Airfare voucher value is \$250 and may be used towards airfare or air + hotel packages booked by Allegiant, be applied to convenience fees, baggage fees and taxes. Vouchers are only valid when redeemed online at www.allegiant.com or through the reservation center at 702.505.8888. The voucher is not redeemable for cash and is valid only toward one transaction. No change or credit will be issued, and it is not valid toward any onboard purchases. Balances not used on the initial booking will be forfeited. Allegiant reserves the right to cancel, alter routes/ times or suspend air service without notice. Not all air service is year-round, so some destinations may not be available at the time of booking. The voucher is valid for one year from the date of issue. Travel must be booked and completed prior to the expiration date listed on the voucher. Lost or stolen vouchers will not be replaced, and the expiration date cannot be extended.
- C. Allegiant Air and the Board are not responsible for, and will not pay, expenses associated with transportation on other carriers, ground transportation, baggage charges or overnight lodging, if required.

The Board is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online participant's ability to participate in the Sweepstakes, and any injury or damage to participant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the Sweepstakes.
- 5. **Publicity; Use of Personal Information.** By participating, where allowed by law, all participants and winner(s) grant the Board and Allegiant Air exclusive permission to use their names, characters, photographs, voices and likenesses in connection with promotion of this and other sweepstakes and waive any claims to royalty, right or remuneration for such use. - 6. **Release.** By participating in the Sweepstakes, each participant and winner waives any and all claims of liability against the Board, its employees and agents, Allegiant Air and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Sweepstakes, or from the use of any prize. By participating in the Sweepstakes, each participant and winner completely releases social media and radio outlets from any liability of any kind arising out of or related to the Sweepstakes.

resolve any disputes, conflicting claims or ambiguities concerning the rules or the Sweepstakes. The Board's decisions regarding such disputes shall be final. If the conduct or outcome of the Sweepstakes is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Board, the Board reserves the right to terminate this Sweepstakes or make such other decisions regarding the outcome as the Board deems appropriate.
