



OFFICIAL PROMOTION RULES (the “Official Rules”)

VOID WHERE PROHIBITED OR RESTRICTED BY LAW. ALL UNITED STATES FEDERAL, STATE, AND LOCAL LAWS APPLY. NO PURCHASE OR PHOTO PARTICIPATION NECESSARY TO ENTER OR WIN.

General Description:

The Las Vegas Trip Giveaway (the “Promotion”) is conducted by Blue Grass Airport (“Sponsor”). Registration for the Promotion must be completed at Giveaway Link. Upon registration, all participants unconditionally agree to and accept these Official Rules.

Promotion Period:

April 27, 2026, from 12:00 am EST–May 10, 2026, 11:59 pm EST (the “Promotion Period”).

Eligibility:

The Promotion is open to anyone age twenty-one (21) and over as of the exception where prohibited or restricted by law. Participants can only win one prize once per year if valued over \$300. Sponsor, and its respective parent, subsidiaries and affiliated companies, retailers, sales representatives, dealers, distributors, licensees and the advertising, fulfillment, prize sponsors and other agencies involved in the development and administration of this Promotion and each of their respective officers, directors, employees, representatives and agents (collectively, “Promotion Parties”), and the immediate family members (spouses, parents, children, and siblings and their spouses) and household members of each (whether related or not), are not eligible to participate or win.

Selection of Winners:

The winner (a "Prize Winner") will be selected by random drawing on Monday, May 11, 2026 at 10:00 am EST. The Prize Winner will be contacted by email or phone.

If any Prize Winner cannot be contacted within two (2) calendar business days of the first notification attempt, if any Prize or Prize notification is returned as undeliverable, if any Prize Winner rejects his/her Prize, or in the event of non-compliance with these Official Rules and requirements, such Prize will be forfeited, and an alternate Prize Winner will be selected from all remaining eligible entries.
